Participation Fees: This event is proposed by the Council to receive support from the Ministry of Commerce under the MAI Scheme, and we are currently awaiting the Ministry's approval. Once approved, the MAI subsidy will be available exclusively to the top 30 companies that submit a completed application form along with full payment, on a First Come First Served basis. While we await the Ministry's decision, the Council is currently charging subsidized rates. Your participation will be under the Indian Silk Export Promotion Council's brand, and we are committed to providing personalized services to our members around the clock.

It is important to understand that this fee excludes costs for airfare, hotel accommodations, shipping display materials, and other associated expenses. We have submitted a request to the government for MAI support, which is currently pending. Given the limited availability of corner booths, allocations will be made on a first-come, first-served basis, taking into account various factors according to their established guidelines.

MAI Funding:

This event is one of the initiatives proposed by the Council to receive support from the Government of India under the MAI Scheme and is currently pending approval. Once the competent authority grants approval, the Council will arrange for the reimbursement of the applicable subsidy amount. Additionally, exhibitors are eligible to request reimbursement for economy class airfare taken via the shortest route under the MAI for qualifying member participants, in accordance with the MAI criteria outlined below:

1. Exporters who have previously utilized subsidized fees under the MAI scheme three or more times, including past participation (through any Export Promotion Council) in this specific event, are not eligible for subsidy under the MAI scheme for this edition.

2. An exporter may benefit from the MAI for participation in a maximum of three approved MAI events within a financial year. However, exporters from SC/ST/Women categories, as well as those with an f.o.b. export value of Rs. 50 crores or less in the previous year, are permitted to participate in five events annually, provided each event is in a different market (e.g., Africa, LAC, WANA, ASEAN, etc.);

3. Furthermore, participants who have maintained membership with the Council for 12 months and have a minimum annual export turnover of Rs. 50 lakhs and up to Rs. 50 crores in the last financial year (2024-25) will qualify for reimbursement of economy class airfare. Reimbursement for airfare for companies with no exports, startups, or new **exporters may be granted for up to 10% of the total participants, subject to the following conditions:** (a) The reimbursed airfare will cover 50% of the economy fare, adhering to the market-specific ceiling set forth in the scheme guidelines. (b) The exporter must be active in the domestic market with a minimum annual turnover of Rs. 50 lakhs in the preceding financial year. The reimbursement will be capped at Rs.90,000 for economy class air travel or the actual cost incurred, whichever is lower. This amount is subject to final approval and the availability of funds from the Ministry, and it applies only to eligible exhibitors with an export performance of Rs.50 lakhs or more.
